

**RESOLUTION NO. 21- 053**

**THE BOARD OF COUNTY COMMISSIONERS  
OF PUEBLO COUNTY, COLORADO**

**APPOINTING A CHAIRPERSON AND VICE CHAIR TO THE PUEBLO COUNTY  
LIQUOR AND MARIJUANA LICENSING BOARD**

**WHEREAS**, the Board of County Commissioners, by Resolution No. 05-038, dated February 9, 2015, amended the Pueblo County Code, Title 5, with the addition of Chapter 5.16 creating the Pueblo County Liquor and Marijuana Licensing Board, as amended, to act as the local licensing authority for Pueblo County, Colorado, for the licensing of dance hall, liquor and marijuana establishments as authorized by Articles 18, 43.3, 43.4, 46, 47 and 48 of Title 12, C.R.S.; and

**WHEREAS**, the officers of the Board shall consist of the Chairperson and Vice Chair, with terms expiring January 31, 2022, there exists two (2) vacancies on the Board for both Chairperson and Vice Chair, and three current members serving on the Pueblo County Liquor and Marijuana Licensing Board submitted their interest for appointment as Chairperson or Vice Chair; and

**WHEREAS**, this Board has reviewed said applications and desires to appoint Kim Archuletta as Chairperson and Brian Casaus as Vice Chair to the Pueblo County Liquor and Marijuana Licensing Board for terms beginning on March 1, 2021 and expiring on January 31, 2022.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Pueblo County, Colorado, that:

1. Kim Archuletta is hereby appointed as Chairperson to the Pueblo County Liquor and Marijuana Licensing Board for terms beginning on March 1, 2021 and expiring on January 31, 2022.
2. Brian Casaus is hereby appointed as Vice Chair to the Pueblo County Liquor and Marijuana Licensing Board for terms beginning on March 1, 2021 and expiring on January 31, 2022.
3. Said appointed members will serve at the pleasure of the Board of County Commissioners of Pueblo County, Colorado.
4. The staff to the Board is authorized and directed to notify the Commission of the appointments by providing them with a copy of this Resolution.
